#### "between two independent parties"

- within a defined region
- define respective responsibilities, interests and liabilities
- for the purpose of performing and completing a contract for services



# "scope of the agreement"

- not to be interpreted as to create any permanent relationship between the two parties
- Set term (in good faith) agree to continue under similar or revised terms



- "contracts award"
- contracts to be entered into under the name of the supply company
- equipment, materials, supplies and other property acquired during the JV shall be held jointly by the Parties



### "Percentage of Participation"

- profits received in connection with the performance of the contracts
- interests in all property and equipment acquired
- losses which arise our of or resulting from the activities of the JV



# "Policy Committee"

- Certain matters, issues and decisions
- Representation as per percentage share
- Unanimously approve service rates, intercompany purchases, working capital requirements, and other defined decisions



# "Managing Party"

- Casts the deciding vote in the event of a tie
- Implements the decisions of the Policy Committee
- Fully manages the JV
- Decisions binding upon the parties
